A. Change of Status from Society to Trust:

To effect a change in the status of the organization, which is of the similar object as the present Trust, which till now is known under the name and style of 'Dyavappanavar - Valasang Education Academy', and which is registered as a society under Karnataka Societies Registration Act 1960 into the Trust under the name and style of 'Dyavappanavar - Valasang Educational & Academic Trust' with the same members of the Society, who are the Trustees of the present Trust also.

B. Education :

Which without in any way taking away the generality of its meaning, will include the following objects, namely :

- I To establish, take over, maintain and run, develop, extend grant to and donate for educational institutions including schools, from nursery level to higher secondary level, for the promotion and practice of fine arts and science and commerce and to aid in every possible manner such schools, colleges, polytechnics, vocational training centres, research centres and audio-video educational centres and hostels for students pursuing their studies.
- II To institute studentship, scholarships, stipends, medals, prizes etc to help and encourage deserving students and to provide monetary help to students, scholars and teachers for the purpose of and towards the imparting of education.
- III To establish, maintain, develop and donate for the establishment, maintenance and development of book-banks, libraries and hostels.

7. That the trust hereby created shall not be revocable either at the instance of the Authors, or any body else, at any time and under any circumstances.
8. The term Trust Property shall be and include the said sum of Rs.5000/- (Rs. Five Thousand only) set apart by the authors and further grants, donations and contributions and / or property movable or immovable, that may be made by the Author or by others from time to time and other accumulations and accretions thereof in whatever form they may be varied from time to time.
9. The Trust property shall vest in the Board of Trustees who shall hold, manage and administer the Trust in accordance with the terms and provisions thereof.
10. The Board of Trustees shall accept assets, gifts, donations or contributions from the general public to run and to achieve the objects of the Trust.





- J. If the President and the Secretary of the Trust are of the opinion that any of the Trustees is guilty of any acts which is contrary to the objectives or interests of the trust then the President and the Secretary of the Trust may expel such Trustee from the Board of Trustees and also from the trust, without assigning any reasons whatsoever.

- d. To accept assets, gifts, donations or contributions in so far as they are not inconsistent with the objects of the trust and all such assets, gifts, donations and contributions shall form part of the corpus of the trust, unless it is otherwise specifically given in writing by the donor.
- e. To establish committees, sub-committees and other such institutions having similar objects of those of this trust as may be necessary for proper management and administration of the trust and the strength and the duration of such committee and or sub-committee or institution shall be decided by the President and the Secretary of this trust.
- f. The constitution of the respective heads and the office bearers of the committee, sub-committee or the institution shall be decided by the President and the Secretary of this trust.
- g. If the President and the Secretary of this trust are of the opinion that any member or office bearer of the trust, institution, committee or sub-committee is guilty of any acts contrary to the objectives of the trust, they may order expulsion of such member or office bearer, without assigning any reason.

14. POWERS OF THE PRESIDENT AND THE SECRETARY:

WITHOUT prejudice to the generality of the powers, the President and the Secretary shall solely exercise the following powers for efficiently and effectively transacting the business and for the attainment of the objects of the trust.

- iv. To withdraw any power or revoke any appointment of any employee or any attorney.
- v. To sell any movable or immovable property belonging to the trust.
- vi. To let any portion of the immovable property forming part of the Trust Fund at such rent and for such period and on such terms and conditions as the President and the Secretary may think fit and accept the surrender of any lease.
- vii. To raise loans on the mortgage of the trust properties movable or immovable.
- viii. To borrow funds with or without security of the property and for this to mortgage charge and encumber any asset, movable or immovable.
- ix. For the purpose of carrying out the activity spelt out in clause ' VI ' above, to take out, register trademarks, copy rights, patents etc, as and when felt necessary and expedient.
- x. Provided further that any or all these powers can be exercised by any trustee or group of trustees on being so authorized by the President and the Secretary of the Trust.

15. ACCOUNTS:

- a. The trustees shall keep proper of accounts of the income and expenditure of the trust which shall be closed every year on 31st of March. The books of accounts of the trust shall be audited by a chartered accountant and a certificate obtained. These certificates shall be in the custody of the President of the Trust.
- b. The trustees shall at all times stand indemnified in respect of any act that may have been done by them in respect of matters related to the trust. But however, the trustees shall not be entitled to any remuneration.
- c. These powers of the trustees shall be so exercised as to ensure that the income of the trust would be exempted u/s 11 of the income tax act, 1961 as read with sections 12, 12A amended from time to time. It is clarified that the power of the investment of the funds including those mentioned in clause '13 C' above shall be exercised in accordance with the provisions of section 11 of The Income Tax Act, 1961 read with sections 13 so as to ensure exemption from levy of income tax.

16. MEETINGS:

- a. The board of trustees shall meet at least once in three months provided that if the President of the trust so requires, he may adjourn the meeting for reasons to his satisfaction.
- b. The notice of not less than seven days in writing shall be given to all the trustees, of the meeting being held. However, the President of the trust may call a meeting in cases of emergency bringing the same to the notice of the trustees within 24 hours.

- c. The board of trustees shall be authorised to frame rules for the proper administration of the trust but such rules shall not be against any provisions or objects of the trust.
