

- D. The President and the Secretary of the Trust shall also have the power to remove or terminate any trustee or trustees at any time from the Board of Trustees for the reasons the President and the Secretary may think fit and or in the best interest of the trust.
 - E The term of office of the First President and the First Secretary of the Trust as stated in clause '12 B' above, shall be for life.
 - F In the event of demise of the existing permanent President or the permanent Secretary of the Trust, the seniormost surviving successor of the deceased as defined in the Hindu succession Act shall become the President or the Secretary, as the case may be.
 - G The Successor to the President or the Secretary of the trust shall continue for their life time from the date of assumption of the office by such successor.
 - Any person who is to be inducted as a Trustee into the above Trust, other than by the provisions herein above stated in clause 'F' supra the same shall be at the discretion of the President and Secretary of the Trust. Such trustee shall be governed and bound by the terms and conditions incorporated in this Deed of Trust.
 - Among the Trustees constituted under this Deed, the President
 Shri Grurushant S/o. Veerappa Valasang and the Secretary Shri Mahesh S/o
 Hanumanthappa Dyavappanavar shall be permanent Trustees and their Successors referred to para 'F' above shall be permanent Trustees.

If the President and the Secretary of the Trust are of the opinion that any of the Trustees is guilty of any acts which is contrary to the objectives or interests of the trust then the President and the Secretary of the Trust may expel such Trustee from the Board of Trustees and also from the trust, without assigning any reasons whatsoever

- To accept assets, gifts, donations or contributions in so far as they are not inconsistent with the objects of the trust and all such assets, gifts, donations and contributions shall form part of the corpus of the trust, unless it is otherwise specifically given in writing by the donor.
- To establish committees, sub-committees and other such institutions having similar objects of those of this trust as may be necessary for proper management and administration of the trust and the strength and the duration of such committee and or sub-committee or institution shall be decided by the President and the Secretary of this trust.
- f. The constitution of the respective heads and the office bearers of the committee, sub-committee or the institution shall be decided by the President and the Secretary of this trust.
- g. If the President and the Secretary of this trust are of the opinion that any member or office bearer of the trust, institution, committee or sub-committee is guilty of any acts contrary to the objectives of the trust, they may order expulsion of such member or office bearer, without assigning any reason.

14. POWERS OF THE PRESIDENT AND THE SECRETARY:

WITHOUT prejudice to the generality of the powers, the President and the Secretary shall solely exercise the following powers for efficiently and effectively transacting the business and for the attainment of the objects of the trust.

- vii. To raise loans on the mortgage of the trust properties movable or immovable.
- viii. To borrow funds with or without security of the property and for this to mortgage charge and encumber any asset, movable or immovable.
- For the purpose of carrying out the activity spelt out in clause 'VI' above, to take out, register trademarks, copy rights, patents etc, as and when felt necessary and expedient.

15. ACCOUNTS:

- a. The trustees shall keep proper of accounts of the income and expenditure of the trust which shall be closed every year on 31st of March. The books of accounts of the trust shall be audited by a chartered accountant and a certificate obtained. These certificates shall be in the custody of the President of the Trust.
- b. The trustees shall at all times stand indemnified in respect of any act that may have been done by them in respect of matters related to the trust. But however, the trustees shall not be entitled to any remuneration.
- These powers of the trustees shall be so exercised as to ensure that the income of the trust would be exempted u/s 11 of the income tax act, 1961 as read with sections 12, 12A amended from time to time. It is clarified that the power of the investment of the funds including those mentioned in clause '13 C' above shall be exercised in accordance with the provisions of section 11 of The Income Tax Act, 1961 read with sections 13 so as to ensure exemption from levy of income tax.

16. MEETINGS:

- a. The board of trustees shall meet at least once in three months provided that if the President of the trust so requires, he may adjourn the meeting for reasons to his satisfaction.
- b. The notice of not less than seven days in writing shall be given to all the trustees, of the meeting being held. However, the President of the trust may call a meeting in cases of emergency bringing the same to the notice of the trustees within 24 hours.

- The beneficiaries of the trust shall be chosen without regard to caste, creed, community or gender of the individual.
- g. The President and the Secretary of the trust shall at all times, during their continuance in office, have the right to delegate their powers to any of the remaining trustees or to other attorneys or agents as they may think fit.
